

# Qhia Txog Nyiaj Txiag rau Ntawv Kho Mob Kom Pheej Yig Los Ntawm MNsure



MNsure yog ib qho chaw ua luam uas cov neeg nyob hauv Minnesota yuav tuaj yuav kev pab them nqi kho mob, muab coj los sib piv, thiab xaiv txoj kev pab them nqi kho mob uas haum qhov lawv xav tau, thiab nws yog tib qho chaw kom txais tau kev pab nyiaj.

MNsure yog tib qhov chaw uas cov neeg nyob hauv Minnesota mus nrhiav tau cov kev pab uas pheej yig tshaj cov ntawv kho mob, nrog rau:

- Muaj cov se qhab nes uas txo qhov nqi them txhua lub hlis
- Koom-them kom txo cov nyiaj rho hauv hnab ris xws li cov deductibles thiab cov co-pays

Cov neeg nyob hauv Minnesota kuj thov tau Medical Assistance dawb thiab MinnesotaCare los ntawm MNsure.

Qhov nyiaj se pub dawb hu ua Expanded premium tax credits tau muab ncuu kom ntev los ntawm tsoom fww Congress. Cov neeg es tsim nyog tau txais cov nyiaj savings nov mas tsis yog saib los ntawm cov nyiaj khwv tau hauv tsev neeg rau xyoo 2024.

## Hom Kev Pab

### Hom Ntawv Kho Mob Uas Yuav

Kuj muaj npe hu ua “hom kev pab uas tsim nyog” los yog QHPs, Hom ntawv kho mob no muaj los ntawm cov txhuam txhab muag ntawv kho mob. Cov se qhab nes (tax credits) muab rau koj yog txiav txim muab raws li koj tsev neeg coob npaum cas thiab khwv tau nyiaj npaum cas, thiab cov nqi ntawm daim ntawv kho mob kim npaum cas ntawm thaj chaw koj nyob. Cov ntawv kho mob yuav tsum mus yuav ntawm MNSure mas thiaj li tsim nyog tau txais se dawb.

### MinnesotaCare

Pab kho cov neeg nyob hauv Minnesota uas khwv tau nyiaj tsawg uas nrhiav tsis tau ntawv kho mob phee yig thiab tsis tsim nyog tau txais ntawv kho mob los ntawm Medical Assistance. Nqi them pheua hli phee yig mas soj ntsuam los ntawm koj tsev neeg thiab kev khwv tau nyija ntau npaum li cas.

### Medical Assistance

Minnesota cov kev pab Medicaid pab cov neeg uas khwv tau nyiaj tsawg, tshwj xeeb yog cov menyuam thiab cov poj niam muaj menyuam hauv plab. Tsis muaj qhov yuav them nqi txhua lub hlis.

Cov neeg uas txawj ua hauj lwm hauv cov koom haum zoo hauv lub koog zej zog yeej tuaj pab tim ntsej tim muag ua tsab ntawv thov thiab kev rau npe pub dawb thiab yuav rov qab los pab ntiv.
