PDM Pilot

Objective:

Field test PDM functionality before full deployment

Proposal:

- Conduct state-wide turn-on, turn-off beginning in July after 18.2 release.
- One full cycle of PDM, not affecting open enrollment.
- Counties to collect feedback from "super-user" counties and report back to DHS.
