

# Submitting an Application to Contract with MNsure

### Step 1: Create an Agency Management Program (AMP) Account

In order to submit an application to contract with MNsure, you will need to create an account in the Agency Management Program (AMP). To begin, click on the link "<u>Create an account to</u> <u>submit an application</u>" under Becoming a Partner. (https://www.mnsure.org/assister-central/navigator-one-stop/amp/account-create.html)

To create an account, enter your first name, last name, your unique email address (which will be your user name) and create a password.

Click "Submit" and you will get a confirmation on the next screen that your request has been received.

You will receive an email to confirm your email address. You must click on the link in this email before you can log in to your account.

Note:

- The email will come from the address "mnsure-no-reply@caspio.com" with the subject: "Email Validation – Agency Management Program (AMP) account."
- It may take several minutes for the email to arrive in your account. Be sure to check your spam/junk mail folder before reporting a problem to <u>navigators@mnsure.org</u>.

### Step 2: Create an Agency

Once you have a validated email address, log in to your AMP account.

Scroll to the bottom of the page and click on "Submit a new application to contract with MNsure."

Enter the legal name of your agency as it should appear on your contract with MNsure. If your agency has a DBA (doing business as) name, you will have an opportunity later to list that as the name MNsure will share in public-facing information.

You will also need to indicate the type of contract you are seeking ("Agency Type"). The Agency Type will be navigator or certified application counselor. Carefully consider the differences between the responsibilities of the <u>types of contracts</u> before creating your agency.



Once you select "Submit" you will be brought back to the Account Management homepage where you will now see your agency appear under "Manage agency."

As the individual who setup the agency account, you are automatically assigned the user role of "Primary Contact/Account Administrator." If that is not your role, you will have the opportunity to change your role before you submit your application and assign someone else from your agency to this role.

## Step 3: Completing an Application

To complete an application to contract with MNsure, click on the "Manage agency" link under your user role.



When you click on "Manage Agency," you will be asked to log in again. This is not an error, but a necessary step to ensure you are authorized to access this agency's account. The system will autofill your Agency ID and Role ID and ask you to enter your email and password. Use the same email and password you used to log in to your individual account.

After logging in, you will land on the Agency Home screen.

You are required to submit an application and complete the contracting process before you can begin to add staff to your roster.

To begin completing an application, click on "Agency Account" on the Agency Home screen.



The application has four sections that will need to be completed before the application can be submitted: Agency Information, Authorized Agency Contacts, Data Privacy and Security Information and Additional Application Questions.

You must complete all sections before you may sign and submit your application.

To begin (or resume) completing an application section, click on the hyperlink to that section, or scroll down the screen.

Click on the "Edit..." link below the section header.



You will need to complete all the required fields with an asterisk (\*). If you do not have all required information at this time, you can click on "Cancel updates and return to detail listing" to exit. You can log back into resume the application when you have the required information.

When you have entered all required information in a section, select "Update" to submit the information for this section.

When completing the Authorized Agency Contacts section, keep in mind:

- If you created the agency account, your information will already be filled in as the Primary Contact/Account Administrator. You can change the Primary Contact/Account Administrator for your organization if that is not your role. The same individual may fill multiple roles.
- Individuals in these three roles will have access to AMP: Primary Contact/Account Administrator, Authorized Representative/Contract Manager, Signature Authority
- When entering contact information for your authorized contacts, be sure to include an email address that is unique to that individual.

### Step 4: Submitting an Application

Once all four application sections have been completed, the individual in the Signature Authority role must sign and submit the application. If you are the Signature Authority, but completed the application logged in using your Primary Contact role, you must log out and log back in again using the Signature Authority role.

You must be signed in as the Signature Authority before you may sign and submit your application.

Your Signature Authority may have more than one role listed. If so, they must log in using the Signature Authority role.

Once logged in select "Agency Account."



If all application sections have been completed, the Signature Authority will see a link to Sign and Submit Application.

After entering your name and title, select "Submit my signed application." You will be taken back to the Agency Account screen where the status will be updated to show you have signed and submitted an application.

MNsure will contact you if there are any questions regarding the application. While your application is being reviewed, you cannot access other features of AMP.

If your application is approved, you will receive an email with a completed contract to sign and submit. After your contract has been fully executed with MNsure, you will be able to add staff through AMP to begin the certification process.
